Dear members of the Board of Selectmen,

I need to inform you off an incident that happened on Tuesday, May 20, 2008, at the town hall of the Town of Holland in the town clerk's office.

On my way to the town clerk's office to pickup some documents, I was driving up Sand Hill Road and came to a stop at the intersection with Sturbridge Road. As I was stopped at the intersection, a pickup truck from the Highway department was passing the intersection towards the Dam. Brian Johnson, Highway Surveyer and son of one of the members of this Board was driving the pickup truck.

I parked my car in front of the town hall and went upstairs into the clerk's office. Kristin Laplante the town clerk, who is also the secretary of the Highway Department handed me the copies I needed and was issuing a receipt for the copies when Brian Johnson entered the clerks office.

I said to Brian, "Hi Brian, how is the road business?"

Brian: "I don't need to talk to you!"

I answered: "Yes, you are right; you don't need to talk to me."

Brian: "As far as I'm concerned you are nothing more than WHITE TRASH! You and your friend James Lamountain are all the same, WHITE TRASH!"

I said: "Brian, you just make it more difficult for yourself."

Brian: "What 's that suppose to mean?"

I said: "I will just dig deeper and find more stuff about you and your family"

Brian: "Do you want to tell me that what you are doing down there is all legal?"

I said: "YES!"

Brian: "You are just a SCUM BAG! You and your friend Lamountain are all the same SCUM BAGS, nothing more .. WHITE TRASH!"

I said: "There is James Lamountain and there is Peter Frei, we are separate people. I'm not responsible for his actions and he is not responsible for my actions."

Brian: "You are just a SCUM BAG, that's what you are!"

I said: "How dare you to call me a scum bag and white trash."

Brain: "YES, THAT'S WHAT YOU ARE, A SCUM BAG AND WHITE TRASH!"

I took the receipt and left the town clerk's office.

Brian Johnson's slanderous attack is despicable and an attempt to intimidate.

After I initiated legal proceedings to enforce the zoning laws under M.G.L. and local bylaws in connection with two dwellings built by the Johnson family in violation thereof, and the potential of an order to have the two illegally built dwellings demolished, Brian Johnson's action constitutes "intimidation of a witness," a felony under M.G.L.

Brian Johnson is directly affected by the enforcing action initiated by me. Brian Johnson is an elected official of the town of Holland, he is the son of Earl Johnson, he is the brother of Carl and Eric Johnson, the two individuals who built the two dwellings that are in violation of the zoning laws and eventually ordered to be demolished by a court of law. Furthermore, Brian Johnson is the owner of the third parcel of land created by the ANR that was endorsed by circumventing the subdivision control law. My actions will prevent Brian from building on said lot or sell the lot as buildable lot as it will no longer be a buildable lot.

Does this Board tolerate or even condone this kind of conduct inside the town hall by one of the elected officials?


I will not tolerate this kind of treatment. I have the right to feel safe as a member of this community. I have the right not to be harassed and humiliated in front of the town clerk. The town clerk has the right not to be put into such a situation.

I request that this Board commence elected and/or appointed an investigation and calls for a public hearing to discuss potential disciplinary actions against Brian Johnson.

I will not cease to exercise my right to freedom of speak, my right to file legal actions against any corrupted officials of this government, whether elected and/or appointed; these rights are granted to each human being under the First Amendment of the Constitution of the United States.

The violations of my civil rights perpetrated by different officials of this town are systemic and have to stop.
