Voluntary Statement

I, Peter K. Frei voluntarily make the following statement (statement 3 pages, picture of the mentioned assailant for identification on page 4) to the Holland Police Department on this day, the 25 day of the month of February of the year 2011.

I hereby certify that the facts contained herein are true and correct to the best of my knowledge. Any False statement(s) made are punishable under the penalties of perjury pursuant to G.L. Chapter 268, Section 1 & Section 1A.

A group of eight men arrived around 6:20 am on Saturday February 19, 2011, started drilling holes using three or four power augers which had no silencers within a distance of 50' to 200' all around my house and started drilling holes. Among these men were, Brian Johnson, individual shown in the attached picture which I believe to be Albert West (thereafter "the assailant", Michael Rutkowski, Kyle Rutkowski, Arti Folger(?) and three other male individuals. All men were drinking beer all day long, driving their quads close to my house revving up their engines. Michael Rutkowski's quad had the words "EAT ME" sprayed on the plow and he always parked it in a way that the plow was facing my house. They setup a folding table in the midst of the path I walk to get to my car and to my mailbox at the spot the cove to the south of my house meets the point where the path leads from my property onto the frozen lake.

Around 3 pm some of the men were trespassing onto my property. I went to tell them that they are trespassing and they should stay off my property.

Dana Manning who was staying with me the night before and was with me that morning and never left the house until 3 pm warned me as she was in fear that Brian Johnson and his gang could physically hurt me. She suggested to videotape me walking to the mailbox and back, and that I should record audio with my I-phone, just in case they would attack me.

On my way back to my house I was following my regular path which is the shortest distance between my car, my mailbox, and my house. As I stepped on the ice, I wanted to tell Brian Johnson and his gang that I would not tolerate them trespass my property.

Brian Johnson said something to me which I did not understand, I asked:

**"Are you talking to me, hu?"**

Brian Johnson said:

**"sn't there somebody else in the house?"**

I answered:

**"hu?"**

Brian Johnson:

**"What do you want?"**

I said:

**"You know that that's my property..."**

The assailant, followed by others:

**"Get the fuck out of here!"**

I noticed that the assailant was in the process of taking off his winter jacket and I realized that Brian Johnson's gang was about to give me a good "gang-beating."

Brian Johnson:

**"GET THE FUCK OUT OF HERE, RIGHT NOW!! YOU BETTER GET THE FUCK OUT OF HERE!!"**

While Brian Johnson was still talking, the assailant kicked me in the back of my lower legs and I fell backwards on the ice.

As I was lying on the ice, Brian Johnson positioned himself in a way so he could kick me in my head. As he started taking a swing with his right foot, I started laughing and said:

**"That's great.. you know what.. because she is videotaping.. hahaha.."**

Everybody froze immediately, Brian Johnson:

**"huhuhu"**

I said again:

**"that's just great.."**

I got up and walked towards the house. Once in safety, I called 911.

The time between Brian Johnson saying, "GET THE FUCK OUT OF HERE, RIGHT NOW !!" and the moment the assailant kicked me was four seconds.

Officer Bean arrived about half an hour later and interviewed me. Bean noticed that I was bleeding on my left hand. Sergeant Jeffrey Forcier arrived a while later. Brian Johnson and his gang were still there at the time Forcier arrived.

I played the audio recording of the assault to Officer Bean and sergeant Forcier. As I never saw the assailant before, I suggested to Forcier and Bean to go over to Brian Johnson's gang to point out the assailant and to get his name for a positive identification.

Officer Forcier refused stating:

"I do not want to escalate the situation.."

I responded:

"How can the situation escalate with two police officers present?"

Officer Forcier had made up his mind and refused.

After the two officers refused to give me an opportunity to point out the assailant, Dana Manning went out by herself armed with a little camera to get a picture of every member of Brian Johnson's gang.

I swear under the pains of penalties for perjury that the above is true,
